TERMS OF SERVICE AGREEMENT

THIS TERMS OF SERVICE AGREEMENT ("TOS") IS A LEGALLY BINDING AGREEMENT BETWEEN FIRST AMERICAN PROFESSIONAL REAL ESTATE SERVICES, INC., A CALIFORNIA CORPORATION, OPERATING THROUGH ITS NATURAL HAZARD DISCLOSURE ("JCP-LGS") DIVISION AND YOU ("LICENSEE") CONCERNING THE WEBSITE ("SITE") AND NATURAL HAZARD DISCLOSURE ("NHD") REPORTS. BY ACCESSING THE NHD REPORTS AND/OR SERVICES PROVIDED THROUGH THIS WEBSITE, YOU ARE AGREEING TO ALL THE TERMS AND CONDITIONS OF THIS TOS, AND THE TERMS AND CONDITIONS SET FORTH IN THE NHD REPORTS.

1. **Definitions.**

1. "**JCP-LGS Content**" shall mean all editorial content, graphics, data and information contained in the NHD REPORTS and on the Site (collectively, the "JCP-LGS Content").
2. "**NHD REPORTS**" shall mean the products and services available for license on this Site. The NHD REPORTS include, but are not limited to, the natural

hazard disclosure reports that are available through disclosures.com, reodisclosure.com and fanhd.com.

2. **Access.** Provided that You comply with all the terms and conditions of this TOS, JCP-LGS agrees to provide You with access to the Site which contains the NHD REPORTS. 3. **Term; Termination.** The term of this TOS will commence upon Your acceptance of the TOS terms (by clicking "I Accept") and continue in perpetuity, unless sooner terminated pursuant to the terms hereof or a governing Services Agreement (the "Term"). Notwithstanding the foregoing, upon written notice to You, JCP-LGS may immediately terminate this TOS, and terminate Your access to and use of the Site, and the NHD REPORTS, if:
 1. JCP-LGS ceases to offer the Site, Software or NHD REPORTS or,
 2. You fail to comply with any of the terms of this TOS.
 3. JCP-LGS may also terminate this TOS, for any reason whatsoever, in its sole discretion, by giving You thirty (30) days advance notice.
4. **Grant of Licenses.** Subject to the terms and conditions of this TOS, and provided that Licensee has paid all applicable fees to JCP-LGS for the use of the NHD REPORTS and that You have not breached the provisions of this TOS or any other agreement between You and JCP-LGS, including a Services Agreement, JCP-LGS grants to You during the Term and within the United States a limited, revocable, non-exclusive, non-sublicensable and non-transferable license to use the Site, and NHD REPORTS, solely as set forth in this TOS. The license granted by JCP-LGS to You hereunder (the "License") is conditioned upon Your compliance with the terms and conditions of this TOS.
5. **Acceptable Use.** You acknowledge and agree that Your use and access of the Site, and the NHD REPORTS may be logged and monitored. You agree to use the Site, and the NHD REPORTS, in a manner consistent with any and all applicable laws, rules and regulations as well as the terms and conditions set forth in this TOS. You shall not disassemble, create models, analytics, or

derivative works of, decompile, manipulate or reverse engineer the Site, or the NHD REPORTS, and You shall take all necessary steps to prevent any unauthorized use of the NHD REPORTS. You shall not use the Site, or the NHD REPORTS, in any way that infringes or misappropriates JCP-LGS's or any third-party owner's copyright, patent, trademark, trade secret or other intellectual property or proprietary rights or rights of publicity or privacy.

Subject to the limited license provided herein, JCP-LGS reserves all rights in and to the Site, including, but not limited to, the exclusive rights under copyright and other intellectual property and the right to grant further licenses. JCP-LGS and its licensors reserve and retain all copyright, intellectual property and other proprietary rights in and to the JCP-LGS Content, including without limitation, all rights in any public information gathered as a compilation. If You do not perform according to the requirements of this section, JCP-LGS will not be liable. You must also provide sufficient documentation, as deemed appropriate by JCP-LGS, to evidence Your out-of-pocket, actual monetary loss.
11. **Warranties, Disclaimers and Limitations.** TO THE EXTENT ALLOWED BY LAW, JCP-LGS DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, EXCEPT AS OTHERWISE PROVIDED IN THE NHD REPORTS.

12. **Pricing/Billing.** JCP-LGS reserves the right to change the NHD REPORTS pricing at any time without notice. Charges or fees for the NHD REPORTS will be accumulated under the Licensee account number and will be invoiced either through escrow or directly to Licensee, depending upon how Licensee sets up their account.

1. **Payment Processing.** In the event that credit card payments are processed by a third-party card processing company, such third-party card processing company will be contractually required by JCP-LGS to use commercially adequate security and confidentiality measures. That agreement requires the card processing company to use adequate security and confidentiality measures to protect Your payment information. All payment information that You provide through JCP-LGS's website will be transmitted directly to the card processing company over a secure connection. 3. Commercially recognized overnight service with tracking capabilities.

Notices to JCP-LGS shall be sent to 4 First American Way, Santa Ana, California 92707, with a copy to JCP-LGS's counsel at the same address marked Attention: Legal Department. Notices to You shall be sent to the address entered by You in the registration information. Notices or communications shall be deemed properly delivered as of the date personally delivered or sent by mail or overnight service.

15. **Conflicts.** If there is a conflict between the terms and conditions of this TOS and the terms and conditions of any NHD REPORT, the NHD REPORT controls.

16. **Links.** Where JCP-LGS provides hypertext links to other Internet websites on the Site, or in the NHD REPORTS, it does so for informational purposes only, and such links are not endorsements by JCP-LGS of any products or services on such sites. JCP-LGS shall not accept, and shall not incur, any liability for such products or services and makes no endorsement or approval of the same.

17. **Survival.** Upon the discontinuance of use of the Site by You, any and all liability limitations, confidentiality, warranty, indemnity, and claims provision(s), and any other provision that contemplates performance subsequent to the expiration or earlier termination of this TOS, shall survive the termination of the TOS. Upon termination of this TOS by either party, any amounts unpaid by You for outstanding NHD REPORTS shall be immediately due and payable.

18. **General.**

1. The interpretation and construction of this TOS, and all matters relating hereto, shall be governed by the laws of the State of California applicable to agreements executed and to be performed solely within such State. The parties hereby submit to the jurisdiction of, and waive any objection to the venue of Orange County, California in any litigation arising out of this TOS, except as otherwise provided in the NHD REPORTS.
2. You may not assign this TOS or allow third parties, other than Your employees to use the Site without prior written consent of JCP-LGS.
3. JCP-LGS shall not be liable for any delay or failure in its performance of any of the acts required by this TOS when such delay or failure arises for reasons beyond JCP-LGS's reasonable control.

4. If a court of competent jurisdiction finds any provision of this TOS to be invalid or unenforceable as to any person or circumstance, such finding shall not render that provision invalid or unenforceable as to any other persons or circumstances. If feasible, any such offending provision shall be deemed to be modified to be within the limits of enforceability or validity; however, if the offending provision cannot be so modified, it shall be stricken and all other provisions of this TOS in all other respects shall remain valid and enforceable.
